Terms & Conditions

1. Application for Participation

- All interested companies/participants must fill and submit the prescribed application form.
- Submission of the form confirms acceptance of all rules and terms.
- The organizer (Nuvista Exhibitions Private Limited) reserves the right to accept or reject any application without assigning any reason.

2. Booth Allotment

- Booths will be allotted on a "First Come – First Serve" basis.
- Booth location will be determined based on the theme and industrial segment of the exhibition.
- Organizer will try to accommodate preferences, but the final decision lies with the organizer.
- The organizer reserves the right to change booth location even after booking if needed.

3. Terms of Payment

- 30% advance payment is mandatory at the time of booking.
- The remaining 70% payment must be completed by 19th November 2025.
- 100% advance payment is mandatory at the time of sponsorship booking.
- Payment must be made via Cheque/DD/Bank Transfer in favor of Nuvista Exhibitions Private Limited.
- Booth/sponsorship allotment will be confirmed only after full payment is received.
- Legal action may be taken in case of non-payment after booking.
- Under no circumstances will any amount be refunded.

4. Cancellation Policy

- No cancellations will be allowed under any circumstances.
- No refunds will be given even if the exhibition is cancelled due to natural calamities, rain, riots, pandemics, or government orders.

5. Booth Usage Rules

- Display or promotional material outside the booth boundaries is strictly prohibited.
- Subletting or transferring the booth to any third party is strictly prohibited.
- Excessive sound systems or disruptive activities can be restricted by the organizer.
- On-the-spot selling is strictly prohibited inside the exhibition premises.

6. Booth Structure and Additional Requirements

- Each exhibitor will be provided with a basic (9 sqm) booth structure – 1 table, 2 chairs, 1 fascia name board, 1 socket, and 3 lights.
- Additional items (like shelves, TV, glass counters, extra furniture, etc.) must be ordered at least 15 days in advance.
- Additional items will be chargeable separately.

7. Stall Possession

- Booth possession will start 2 days prior to the exhibition at 10:00 AM.
- Final deadline for possession: same day by 6:00 PM.
- Late arrivals may be denied entry by the organizer.

8. Panel Usage / Penalty

- Sticking vinyl or bond on panels is strictly prohibited.
- A fine of ₹2000 per panel will be charged for violations and the exhibitor will bear the cost of any damages.

9. Gate Pass Policy

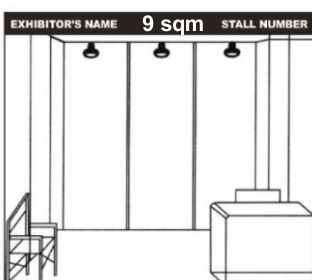
- A gate pass is mandatory for moving any material out of the exhibition premises.
- Gate pass must be collected on the final day for booth clearance.

10. Organizer Rights

- The organizer reserves the right to change the schedule, venue, floor plan or terms without prior notice.
